The Dispenser activates once every 15 minutes; after two hours of operation, enough insecticide is suspended in the air to kill a substantial proportion of the flies, mosquitoes, and gnats present. Usually, the effectiveness will be noticeable within one hour after the Dispenser is activated. If less than 24-hour control is required, the Dispenser should be set to start one hour control is desired and run one hour after control is no longer needed. Keep in mind that such factors as air flow rate, size of space treated, humidity, and room temperatures all affect insect activity and control. Therefore, one unit per 6000 cubic feet is be considered as an average needed with adjustments made depending on specific conditions at place of usage. As with any method of insect control, best results are achieved when sanitation and other positive insect-prevention practices are followed.
